Please find herewith report under Regulation 10(7) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("SEBI Takeover Regulations") in respect of acquisition of 32,83,485 (6.11%) equity shares of Premier Explosives Limited ("Target Company") by Amarnath Gupta jointly with Kailash Gupta (Promoters of Target Company) due to partition of Amarnath Gupta HUF (Promoter of Target Company).

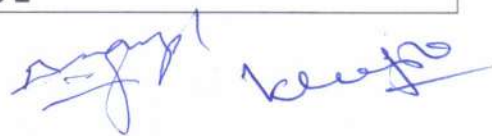

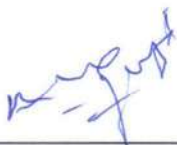
